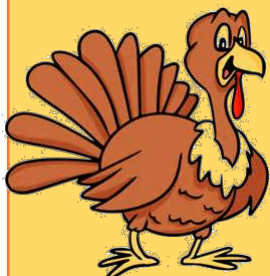

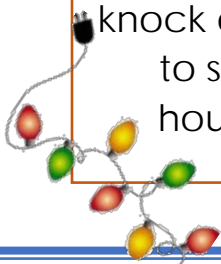


### Holiday Lighting Contest
